Live Scan Fingerprinting & DOJ/FBI Background Check

You will need:

- Request for Live Scan Service form from BSV (with the Berkeley Public Schools Fund's ORI code written in)
- a government-issued photo ID

Go to Cal Live Scan

- Address: 2855 Telegraph Ave, Suite 303 (3rd floor) in Berkeley (just north of Ashby)
- Phone: 510-848-2989
- Hours: Mon-Fri 9:30-6 pm and Sat 11 am 4 pm* (For Saturday, you must call before coming!)
 - o No appointment necessary except call ahead on Saturdays
- Street and metered parking close by
- Remind Cal Live Scan to charge the Berkeley Public Schools Fund account

Note: Fingerprinting results cannot legally be shared between organizations. If you were fingerprinted for a different district or organization in the past, BSV cannot access the results. We are sorry for the inconvenience.

Privacy Notice

Collection and Use of Personal Information. The California Justice Information Services (CJIS) Division in the Department of Justice (DOJ) collects the information requested on this form as authorized by Business and Professions Code sections 4600-4621, 7574-7574.16, 26050-26059, 11340-11346, and 22440-22449; Penal Code sections 11100-11112, and 11077.1; Health and Safety Code sections 1522, 1416.20-1416.50, 1569.10-1569.24, 1596.80-1596.879, 1725-1742, and 18050-18055; Family Code sections 8700-87200, 8800-8823, and 8900-8925; Financial Code sections 1300-1301, 22100-22112, 17200-17215, and 28122-28124; Education Code sections 44330-44355; Welfare and Institutions Code sections 9710-9719.5, 14043-14045, 4684-4689.8, and 16500-16523.1; and other various state statutes and regulations. The CJIS Division uses this information to process requests of authorized entities that want to obtain information as to the existence and content of a record of state or federal convictions to help determine suitability for employment, or volunteer work with children, elderly, or disabled; or for adoption or purposes of a license, certification, or permit. Possible Disclosure of Personal Information. In order to process applications pertaining to Live Scan service to help determine the suitability of a person applying for a license, employment, or a volunteer position working with children, the elderly, or the disabled, we may need to share the information you give us with authorized applicant agencies.

The information you provide may also be disclosed in the following circumstances:

- With other persons or agencies where necessary to perform their legal duties, and their use of your information is compatible and complies with state law, such as for investigations or for licensing, certification, or regulatory purposes;
- · To another government agency as required by state or federal law.
